GUIDELINES TO THE CONTRACTOR

2. The successful tenderer has to supply and configure the UTM at Norka Centre - Trivandrum, on buyback of the existing FortiGate60E.
3. The price quoted shall be all-inclusive full bundle rate for the entire license period and the vendor has to provide maintenance support through out the license period.
4. In cases of any reported fault during license period, vendor has to replace the entire box with a new same model box and in case of absence of same model, the fault reported box has to be replaced with it's higher model new UTM box having same/higher specifications.
5. Price should be inclusive of all transportation costs, installation costs and taxes.
6. Every tenderer should send along with his tender, an Earnest Money Deposit of Rs.500/-. The EMD shall be paid by Demand Draft (crossed) on the local branch of State Bank of Travancore / State Bank of India drawn in favour of the Chief Executive Officer, NORKA-ROOTS, Thiruvananthapuram. The earnest money of the unsuccessful tenderers will be returned as soon as possible after the tenders are settled. No interest will be paid for the earnest money deposited. The cost of tender form [Rs.200/-] may be remitted as separate Demand Draft.
7. Tenderer should enclose all the literature of technical specs, catalogue, customer list etc with the tender document. All technical details must be supported by relevant documents, brochures, pamphlets, technical literature.
8. The tenderers are required to quote both in figures and in words without any cutting/over writing etc. In case of any discrepancy, the lowest rate quoted shall be considered.
9. The successful firm shall be responsible for installation, Commissioning and maintenance of the quoted item.
10. In case, if the agency wish to offer some rebate it must be unconditional rebate so offered by the agency along will be considered.
11. The quantities of items indicated in the schedule are subjected to variation.
12. The tenders are valid for 90 days from the date of opening of tender.
13. The sealed Envelope containing the filled up tender must be superscribed with "Supply and Maintenance of UTM appliance at Norka Roots".
14. The firm should be in the business of UTM appliances at least for the last 5 years (please furnish documents i.e. copy of orders in support of the same). The supporting orders should be of the Govt. organizations only. Details of Past installation shall be produced.

15. Just by quoting the lowest rate does not entitle the agency for the award, the decision on rate reasonability fixed by Norka-Roots will be final and binding.
16. Chief Executive Officer, Norka-Roots reserves the right to accept or reject any or all the tenders without assigning any reason thereof.
17. It is the responsibility of the agency to submit the tender within specified date and time and Norka-Roots is not bound to entertain the tender received late due to any reason.
18. Non-compliance of all or any of the condition in the Tender document will result in the rejection of tenders summarily.
