

HRD Authentication for Educational certificates issued by Private Institutes in Kerala

The Government of Kerala, through G.O (Ms) No. 4/2021/NORKA, has revised procedures for HRD authentication of educational certificates issued by approved private institutions. This process empowers NORKA-ROOTS to authenticate certificates for Government-approved courses conducted by recognized private educational entities.

Accreditation of Private Educational Institutes with NORKA-ROOTS

Procedure:

Submission of Proposals: Government-approved institutions offering recognized courses shall submit proposals at NORKA-ROOTS regional centers (Thiruvananthapuram / Ernakulam / Kozhikode) with detailed credentials for accrediting the respective institutions with NORKA-ROOTS.

Document Verification: Authentication officers will verify the genuineness of submitted proposals by visiting institutions, confirming recognition, and validating course approvals.

Scrutiny and Recommendation: Regional centers will thoroughly examine proposals and, if deemed fit, forward the applications with specific recommendations to the Head Office.

Committee Approval: A designated committee, convening quarterly, scrutinizes proposals received, approves authentications for eligible cases, and enlists them based on specified details.

Authentication and Updates: Upon committee approval, certificates are authenticated through NORKA-ROOTS' Regional Authentication Centers. An updated list of NORKA-ROOTS accredited private educational Institutions and courses will be periodically displayed on NORKA-ROOTS' website.

Clarifications and Exceptions: Any uncertainties or exceptional cases regarding committee decisions will be addressed in subsequent committee meetings, convened as necessary by the CEO of NORKA-ROOTS.

**STANDARD OPERATING PROCEDURE FOR THE ATTESTATION OF EDUCATIONAL
CERTIFICATES ISSUED BY PRIVATE INSTITUTIONS BASED ON THE GUIDELINES**

AS PER

G.O (Ms)No. 4/2021/NORKA DATED 12/03/2021

Government vide G.O (Ms)No. 4/2021/NORKA dated 12/03/2021 had expanded the ambit of HRD attestation authorising to authenticate the certificates issued by private educational institutions recognized by Central/State Government for Government (Central/State)approved courses in Kerala. Vide proceedings dated 12/04/2021, guidelines were issued for enlisting the private institutions, which comes within the ambit of the new guidelines. SOP was also finalized for listing the educational certificates of Government approved courses issued by Government approved institutions which will be HRD authenticated from the Regional Centres of NORKA-ROOTS.

In suppression of the proceedings referred above, revised procedures as detailed below is issued herewith for HRD authentication of the educational certificates issued by the Govt approved private institutions.

Step 1

Government approved institutions conducting Govt. approved courses shall submit their proposal along with the copies of the credentials validating their recognition as detailed below, in the Regional centres of NORKA-ROOTS in Thiruvananthapuram / Ernakulam / Kozhikode requesting for authentication of educational certificates issued by them.

5. Credentials validating the recognition of Institute from Central/State Government bodies
6. Credentials validating the recognition of Course from Central/State Government bodies.
7. Supporting Documents entitling the authority concerned to conduct examinations/issue certificates
8. List of Authorized signatories including specimen signatures

Proposals duly accompanied with the above said mandatory documents alone needs to be accepted in the Regional Centres of NORKA-ROOTS and incomplete proposals may be rejected prima facie.

Candidates holding educational certificates from the Government approved Institutions may escalate their need for HRD authentication of certificates before respective educational Institutions and Institutions may further take up their proposal with NORKA-ROOTS

Step 2

The Authentication Officer/Centre Manager is authorized to verify the genuineness of the proposals. The Centre Manager or authorized Official from the Regional Centre shall visit the institutions to confirm the genuineness of the credentials validating the recognition of Institution/Courses and verify with the originals for ascertaining that the Institution is recognized and the course is approved.

Step 3

The Regional Centres will thoroughly examine the matter scrupulously following the guidelines. If it is found fit for consideration of the Committee, Regional Centres will forward the proposal with specific recommendation to the Head Office for placing it before the committee. The proposal must comprise the following;

- Duration and period in which the Institution was recognized by the Central/State Government
- Details regarding recognition of the institution
- Details of the Approval issuing authority with relevant copies of the recognition certificate
- Duration of course, mode and conduct of examinations and the details of certificate issuing Authority.
- Details of authorized signatory and specimen signatures specifying their period in office.

Step 4

Committee constituted for the purpose shall convene once in 3 months for examining the recommendations received from the Regional Centres. After examining the proposals from the regional centres in a case by case basis, if the committee is satisfied that the claim is a fit case for authentication, then the committee will approve the said educational certificate for authentication and enlist the same with following details and Head Office will forward the certificates to the respective regional offices.

Accordingly the Regional Centres of Norka Roots will initiate steps to authenticate the educational certificates approved by the Committee. The list of certificates shall be updated periodically based on the committee's recommendation. Updated list will be displayed in the website of NORKA-ROOTS.

Step 5

Once approved by the Committee and enlisted, certificates shall be authenticated through the Regional Authentication Centres of NORKA-ROOTS after due verification process.

Step 6

Ambiguity if any, arising with respect to the decisions of the Committee may be placed in the subsequent meetings of the Committee for deliberations.

In exceptional cases and in exigencies Chief Executive Officer, NORKA-ROOTS is authorized to convene the meeting whenever found indispensable.

As per clause (1) clause (4) and clause (16) of the new guideline issued vide G.O(Ms)No. 4/2021/NORKA dated 12/03/2021, ambit of HRD attestation has been expanded by including certificates of all Government recognized private institutions, offering approved courses. Certificate Authentication Centre, Thiruvananthapuram was in receipt of number of requests from candidates possessing different qualification certificates from the Regional Institute of Aviation, Thiruvananthapuram for authentication of certificates. For validating the institute and its courses for a specific period, for the sole purpose of legalizing the certificates by virtue of Clause 16 of new guidelines through NORKA CAC's, an adhoc committee with following officials was constituted by CEO, NORKA-ROOTS.

- i. General Manager, NORKA-ROOTS
- ii. Authentication Officer, CAC-Thiruvananthapuram
- iii. Centre Manager, CAC - Thiruvananthapuram

Subsequently a meeting was convened on 14/07/2021 by the adhoc committee with the Regional Institute of Civil Aviation to submit all required documents to substantiate the eligibility as an approved private institution offering, approved courses under Clause 16 of new guidelines before the committee.

After due verification of documents produced and as per committee recommendations, the Authentication Officers of NORKA-ROOTS at Thiruvananthapuram, Ernakulam and Kozhikode are authorized to authenticate the educational certificates issued from the Regional Institute of Aviation, Thiruvananthapuram for the courses as detailed below subject to prior verification of educational certificate, with immediate effect.

Government vide G.O referred 1st above issued revised guidelines for certificate attestation in conformity with the guidelines issued by MHRD.

As per clause 8 of the guidelines referred 1st above mark lists are attested in following cases:

- I. For those students who wish to join for higher studies in a Foreign University/Institution.
- II. For Qatar Embassy attestation (marklist and bonafide certificate).
- III. As per the specific demand of the Foreign Employer especially to Kuwait and UAE based on submission of specific request from the candidate.

As per Clause 16 (Certificates authenticated with prior verification), all certificates issued by Central/State Governments recognized deemed / autonomous / private institutions are authenticated.

The Certificate Authentication Officer, Ernakulam vide letter referred 2nd above has reported that HRD attestation of consolidated marklist is mandatory for Qatar embassy attestation. Presently the power for HRD attestation of Mark lists issued by autonomous colleges has not been delegated to the Authentication officers and sought clarification in this regard.

The matter has been examined in detail and by invoking the power conferred upon the undersigned as per clause 18 of the guidelines issued vide GO referred 1st above, it is hereby decided to authorise Authentication Officers of NORKA-ROOTS at Thiruvananthapuram, Ernakulam and Kozhikode to authenticate the Marklists issued from colleges (autonomous), subject to prior verification of both degree certificate and mark lists, with immediate effect.


